Dear Mr. John Festa

Thank you for your invitation to use Associated Humane Societies (AHS) as holding facilities for stray animals.

The cost per stray dog would be \$100 and for cats, it is \$90. All dogs arriving receive inoculations for Bordetella, H3NB Killed Flu Virus, deworming, distemper and Frontline. Cats receive 3 x1 inoculations. There is no ceiling amount as to the number of stray cats that will be accepted by AHS. The cost for incoming wildlife is \$25. The municipality would be billed on a monthly basis.

Any sick or injured animals that come to AHS are treated by our veterinarians during our normal operating hours at no cost to the municipality. If we take in an injured/sick stray during night or Sunday emergencies, we will charge the municipality for an emergency care.

If your ACO is out ill, on vacation, etc. and you need the services of our ACO during regular operating hours, from 7:00am – 6:00pm the cost is 95. for the day. If an emergency arises at night or weekends, the cost for the ACO is \$125. per hour. In the event your ACO is on vacation, the cost would be \$95. for an on-call basis.

All animals adopted out are spayed/neutered and are accompanied with a medical guarantee.
