"Interpretive Statement"

This ordinance will revise time limit parking at certain locations within the Maplewood Special Improvement District.

WHEREAS, there has been recommendation to revise certain time limit parking within the Maplewood Special Improvement District; and

WHEREAS, the proposed amendments are in the best interest of the Maplewood Special Improvement District.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Maplewood, County of Essex, State of New Jersey that Chapter 257 of the Code of the Township of Maplewood entitled "Vehicles and Traffic" be amended as follows:

FIRST: Section 257 Schedule XVII: Time Limited Parking be and is hereby amended as follows:

Parking Area #9 hereinafter known as the Baker Street Lot		2 hrs.; 9:00 a.m. to 6:00 p.m. All except Sunday	Block 12.04 - Lot 194.
Ricalton Square hereinafter known as the Ricalton Lot		2 hrs.; 9:00 a.m. to 6:00 p.m. All except Sunday	From behind the property at 156-160 Maplewood Avenue to the area adjacent to 142 Maplewood Avenue.

Woodland Road	East	3 hrs.; 9:00 a.m. to 6:00 p.m. All except Sunday	From Beach Place to a point five hundred fifty (550") feet north thereof.
Woodland Road	South	3 hrs.; 9:00 a.m. to 6:00 p.m. All except Sunday	From Inwood Place to a point two hundred twenty-five (225') feet west thereof.

SECOND: Section 257 Schedule XXV: Parking Permit shall be amended as

follows:

Beach Place	North	6:00 a.m. to 10:00 a.m. Monday to Friday Except Holidays.	From Woodland Road to a point four hundred twenty (420') feet west thereof. DELETED.
Beach Place	South	6:00 a.m. to 10:00 a.m. Monday to Friday Except Holidays	From one hundred (100') feet east of Woodland Road to a point two hundred ten (210') feet east thereof. DELETED.
Highland Place	North	6:00 a.m. to 10:00 a.m. Monday to Friday Except Holidays	From Everitt Place to Ridgewood Road. DELETED.

All other sections shall remain unchanged.

THIRD: Severability

If any section, paragraph, subparagraph, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the specific section, paragraph, subparagraph, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

FOURTH: Repeal of Prior Ordinances

Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance be and the same are hereby repealed to the extent of any such inconsistencies.

FOURTH: Effective Date

This Ordinance shall take effect after final passage and publication and as provided by law.
